



INDBATT



FINBATT


He expressed his confidence in the contingent's ability to live up to expectation in Peace Keeping mission anywhere.

VISITS

UNEF continues to attract a number of distinguished visitors to the Mission area and the months of February and March 1979 were no exception. On 6 February a group of students and staff from the Ghana Armed Forces College led by the Commandant, Air Commodore J.E. Barnor visited the UNEF HQ. The group was briefed by the HQ staff on the UNEF operations and later on visited the Ghanbatt area of responsibility in the Buffer Zone. The tour in the Buffer Zone included visits to the SFM and positions in Ghanbatt location. The visitors have since returned home.

Another visitor to UNEF in the month of February was General Widodo, Chief of Staff Indonesian Army, accompanied by a delegation of high ranking officers including Maj-General Soehodo, Brig Gen. Ismail and Rear-Admiral M. Hatta. The delegation, at the UNEF HQ, called on the Force Commander, Maj-Gen Rais Abin on 12 February and had discussions with him. The visitors were later on given a full scale briefing on UNEF organization and tasks by the staff.

The General and his entourage were at the Indbatt HQ at Wadi Riena to acquaint themselves with operational and other problems of the troops. They also inspected Indbatt positions and attended the Indbatt Medals Day Parade on 14 February. The General in the company of the Force Commander, paid a visit to Ghanbatt HQ the Finbatt HQ and the location of 2 Coy of Finbatt at Ras Malab where a luncheon was organised in their honour. CO Finbatt at the end of the visit presented his command's knife as a friendship gesture to Gen Widodo.

At the time that the Indonesian delegation was in UNEF, another august visitor was also around. He was in the person of Hon Mr. R.C. 

UNEF COMMUNICATIONS UPDATE – PREPAREDNESS FOR A NEW BUFFER ZONE DEPLOYMENT


INTRODUCTION

The UNEF Communications Services were described in the December, 1977 issue of SAND DUNE. The non-military communications provided under the Chief Communications Officer, Svend Rom, were described in considerable detail in the first section of the article. The military portion of the total communications were described briefly in terms of the support rendered by 73 Canadian Signal Squadron's organizational elements. Readers are urged to review that article as a background for the update to the status in December, 1977.

This article highlights the flexibility inherent in both non-military and military communications existing in UNEF to cater for redeployment from the current Contingent dispositions.

NON-MILITARY COMMUNICATIONS

Since the last article, the most significant enhancements to the non-military communications have been the completion of the automatic switchboard installations with 270 lines in ElGala to serve Pollog and Canlog, 180 lines in Ismailia to serve UNEF HQ with all its interfaces, and a 30 line one in Merryland Villa to serve UNEF elements in Cairo at UNTSO Villa, Badawi Block and Merryland itself, and completion of the early phases of the VHF telephone/teletype backbone sub-system with links from Cairo (Merryland Villa) to Ismailia through a repeater site at Gebel Hamza and on to Forward Logistics Base at El Tasa and Swedbatt at Baluza in the Buffer Zone. The totally integrated dial telephone subsystem currently permits contact between subscribers in any of Cairo, Ismailia, El Gala, or El Tasa or Baluza. The next step is to use the VHF telephone link currently serving Ismailia to Baluza to install a link through UP1 relay to Abu Rudeis to provide both telephone and teletype between Ismailia and Finbatt HQ. The arrival of a new Extel teleprinters expected in June 1979 will permit hand copy message



service to interconnect Cairo, Ismailia, El Gala and Buffer Zone Contingent HQs.

In the Motorola VHF radio sub-system, Channel 7 has had to be withdrawn from use due to severe frequency interference problems. In its place channel 8 with a remote transceiver at Gebel Hamza controlled from base station in Ismailia permits contact between radio equipped sites in Cairo and Ismailia plus those radio equipped vehicles on the move in between. A simplified map in Figure 1 illustrates the current deployment of the VHF voice radio repeaters. A facility called "Private Line" is currently being phased into selected channels. This feature provides a toneencoded signal from each transmitter which is decoded by only those receivers equipped with that unique tone code to open the receiver for reception. This feature provides for a great reduction in interference from unwanted calls from those VHF sets which happen to share the same frequency in the very crowded VHF radio spectrum.

The UN Radio Workshop has been expanding its rate of activity as progressively as more VHF radios are taken into use: the UNEF backbone trunk system is expanded with more terminals and repeaters and the system begins to require periodic maintenance. Additionally, planning is underway to prepare for the significant burst of activity which will accompany future operations of the UNEF. The transportable nature of the weatherproofed, air-conditioned shelters with dedicated generator installations provides a high degree of rapid adaptability to a new subsystem configuration for both the VHF repeater sites and the UHF terminal and repeater sites. The large antenna towers can also be relocated once preliminary preparations for foundations, anchors and cabling have been completed at new sites.

The earth station for satellite communications with Geneva and Jerusalem has not been installed pending a possible redeployment of that terminal to Namibia to support the UN Transition Assistance Group being planned there.

MILITARY COMMUNICAITONS

73 Canadian Signal Squadron continues to provide force level HF and VHF voice radio service between UNEF HQ and the Contingents (FINBATT, GHANBATT, INDBATT, SWEDBATT, CANLOG, POLLOG and AUSTAIR) together with the associated Signal Despatch Service, Air/Ground/air communications and line crew support. The Contingents provide their own internal communications

utilizing exclusively VHF radio voice networks. Maintenance and repair services for military signal equipment are provided by 73 Canadian Service Battalion except for some specific national radio equipments which are handled by the Contingent owning the equipment. 116 Air Transport Unit coordinates the provision of UHF and VHF (AM) facilities for the El Gala Air Traffic Control Tower operated by the Egyptians for the airfield.

The existing VHF radio equipment operated by the Contingents is very old and badly worn out. Currently, Chief Communications Officer and Chief Signal Officer are investigating the implications of migrating towards more non-military communications equipment to fulfill the requirements more cost-effectively to that of a program to purchase, operate and maintain replacement military signal equipment. Such a move toward geater use of non-military equipment would have a si-

gnificant impact on the civilian/military ratio of radio and teletype technicians, generator technicians, as well as on the total life-cycle costs of operational spares, spare parts and the associated test equipment. Meanwhile, day to day support of the signal requirements of the contingents as they rotate through the existing deployment continues. UNEF HQ Signal Branch, 73 Canadian Signal Squadron and 73 Canadian Service Battalion personnel continue to strive to render effective signal support through personable assistance, guidance and advice. Contingent signals and operations personnel greatly appreciate that support in siting and maitaining antennas, improving antennas, for fixed sites, keeping generators, rectifiers and battery chargers operational to provide continuous appropriate power, and ensuring adequate grounding for individual safety as well as improved communications.

A COY FROM FINBATT ON DUTY AT UNDOF



During the visit the Governor expressed his grateful and sincere thanks for the great efforts Swedbatt made to help and rescue those two injured men. He also expressed his thanks for all the medical help that Swedbatt had given the bedouins before. As a memory of this the Governor assigned Swedbatt one Sinai plaquet and Six Sinai Medals.








the tape to declare the Depot open in a simple but impressive ceremony.
